Preamble: This Memorandum of Understanding (Agreement) is made and entered into with effect from 07th January 2022, by and between M S Swaminathan Research Foundation (for Community Agrobiodiversity Centre, M S Swaminathan Research Foundation, Puthoorvayal, Wayanad 673 and Sree Narayana Mangalam College, Maliankara, Moothakunnam, Ernakulam, 683516.

Purpose: M S Swaminathan Research Foundation (hereafter referred to as MSSRF), is implementing a Mangrove Restoration project under its ongoing project, HDFC Bank Parivartan — Holistic Rural Development Programme in the villages of Vypin. This MoU pertains to the collaboration of MSSRF with Sree Narayana Mangalam College, Maliankara (hereafter referred to as SNMC) for the documentation of Mangroves of Vypin island and for conducting public awareness programmes.

Duration: This MoU shall be in force and in effect from 07th January 2022 to 30th June 2022 (Phase 1), to be formally renewed at that time if resources permit.

Considerations and Covenants: It is mutually agreed as follows:

1. SNMC shall organize a small group of student volunteers to conduct surveys and mapping of Mangrove resources of Vypin island, and assisting MSSRF to come up with a comprehensive account of Mangrove resources of the locale.

2. SNMC shall help MSSRF in preparing awareness posters and a field guide with information

regarding the Botany, Ecology and Indigenous Knowledge of the Mangroves.

3. While providing technical assistance to the above-mentioned tasks, MSSRF shall be bearing the expenses towards 1) the field logistics, 2) designing and printing of posters, field guide and other awareness materials. The publications out of this work of mutual benefits shall be
