Memorandum of Understanding between ACARR, CUSAT & SNM College, Maliankara

Preamble: This Memorandum of Understanding (Agreement) is made and entered into effect (date), by and between Advanced Centre for Atmospheric Radar Research, Cochin University of Science and Technology, Ernakulam, Kerala PIN: 682022 and Sree Narayana Mangalam College, Maliankara, Moothakunnam, Ernakulam Dist. Kerala PIN: 683516.

Purpose: The MoU pertains to the installation of an Automatic Weather Station (AWS) procured by Advanced Centre for Atmospheric Radar Research (hereafter referred to as ACARR) in the campus of Sree Narayana Mangalam College, Maliankara (hereafter referred to as SNM College) for observing the weather parameters over Maliankara region.

Duration: This MoU shall be in force and in effect from (date) and shall terminate on ((Three years expiry date), to be formally renewed at that time if resources permit.

Considerations and Covenants: It is mutually agreed as follows:

1. The AWS purchased by ACARR under a Project funded by the Ministry of Earth Sciences (MoES), Govt. of India will be installed at the Malankara campus of the College.

2. The College will provide a clean, secure and open space suitable for the installation of

AWS, totally free of cost.

3. The installation of AWS will be carried out under the supervision of ACARR staff and the

complete cost for the same will be borne by ACARR.

4. The college shall provide permission for free access to the installation site by the staff of ACARR and/or authoritative representatives deputed by ACARR for the purpose of installation, inspection, and maintenance or data collection whenever required.

5. All the recurring costs for the maintenance of AWS equipment/sensors shall be borne by

the ACARR.

6. In case either party decides to relocate or dismantle the AWS due to any reason, the entire equipment may be relocated to another suitable site or dismantled from the present location.

- 7. In case ACARR wishes to relocate the AWS to another location due to any reason, ACARR will be free to do so after notifying the College. This MoU will not be a constraint to ACARR for the relocation of AWS if deemed necessary.
- 8. The weather data collected using the installed AWS will be shared with the faculty and students on request basis from time to time totally free of cost, purely for the purpose of non-commercial academic research.
- 9. The AWS facility may be used for taking up joint research activities between the College and ACARR. The post graduate students and faculty from the College may be allowed to use the facilities in the ACARR campus for carrying out Dissertation / Research work.
