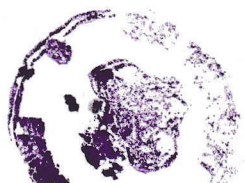

NOW THEREFORE, in consideration of the mutual covenants, terms and conditions and understandings set forth in this Agreement and other good and valuable consideration This Agreement (hereinafter called the "MOU"), effective as of 23/3/2023 is entered into by and between G-Tec and Institutional Partner, and is subject to the terms and conditions specified below.

1. PERIOD OF PERFORMANCE

This Agreement is valid for five years extended up to seven years from the date of execution and is renewable for further additional periods through a written Addendum duly signed by both the parties at the time of renewal.

2. G-TEC RESPONSIBILITIES

- a) Provide ICT enabled certificate courses
- b) Industry Training sessions for the SNM students
- c) Offer Job/career development programs

3. INSTITUTIONAL PARTNER RESPONSIBILITIES

- a) The Institutional Partner will forward the interested students for the courses offered by G-Tec
- b) The Institutional Partner will facilitate basic infrastructure for conducting training programs of G-Tec at SNM College

4. MANAGEMENT

Head of the G-TEC Education and Head of the Institution of the second party will be the responsible to work out operational details of co-operation between the two organizations and ensure proper and effective implementation of this MoU.

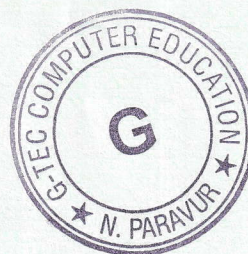
5. NON-DISCLOSURE AGREEMENT (NDA)

8. ENTRY INTO EFFECT, MODIFICATION AND TERMINATION

This MOU will be effective for a period of 5 years from 2023 to 2028 with extensions available upon mutual consent. The course will be conducted at a mutually agreeable and reasonable cost.

This MOU is not intended to be legally binding document. It is meant to describe the nature of, and to suggest the guidelines for, the cooperation described above. Nothing therefore shall diminish the full autonomy of either institution, nor will any constraints be imposed by either upon the other in carrying out elements of this MOU.

This MOU shall become effective when appropriate representative of G-Tec and SNM College, Malinakara affix their signatures below. This Memorandum of Understanding shall remain in force for two years from the date of signing and be subject to revision or modification by mutual consent. Both parties shall discuss and decide on the continuation or revision of the Memorandum six months prior to its expiration.

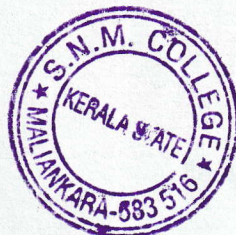
