## **POLICY ON VEHICLE RESTRICTION INSIDE THE CAMPUS**

The institution formulates rules and regulations in accordance with the order issued from the Higher Education (G) Department, Government of Kerala Order No 26483/G1/H Edn dated 12.5.2015, to ensure safe and secure entry of vehicles in the campus premises.

### **OBJECTIVES**

- To avoid accidents within the campus and to ensure safe and secure learning and working atmosphere for our students and staffs
- To regulate the rising commotion during the working hours.
- To ensure that the students abide by the rules and regulations formulated by government.
- To encourage students to use public transport system which in turn triggers the green initiative mission in the campus.

### **MODE OF ACTION**

- All the rules enforced by the motor vehicle authorities are applicable inside the college premises
- We organize awareness sessions on road safety and traffic rules to be followed, useful for our students and the faculty.
- Students and staffs should abide by the government rules and the users should possess valid documents of their vehicle along with their driving license. All documents should be submitted on request by the college authorities.
- Separate parking spaces allotted for the employees and the students.
- Speed limit inside the campus is limited to 10 km/hr
- Students are not allowed to roam around the campus with their vehicles during class hours.
- We strictly prohibit honking of horns inside the campus which causes noise pollution and distraction during the class hours.
- Racing and stunts on vehicles of any kind inside the college premises is a punishable offence.

- On the occasion of special days students are permitted to enter the campus with their vehicles but are permitted to take the vehicles out of the campus only when the programme rounds off.
- The differently abled students can park their vehicles near the concerned classrooms on special request to Principal.
- We encourage our staffs students to adopt eco -friendly means in transport system which can contribute towards our green initiative missions and sustainable development goals for future.
- We promote the use of bicycles electric vehicles among staffs and students which contribute greatly towards green initiative goals.
- The use of public transport system is encouraged to develop green initiative goals.
- The private vehicles of staffs and students should possess a valid pollution certificate inside the campus and it should be presented on request by college authorities.
- The college authorities are not responsible for theft of the user's vehicle outside the campus.
