Biolabs is not liable to make any payment (stipend / salary) for the internships.

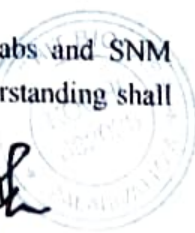




