3. **Academic matters:-** All academic matters like the examination, issue of certificate, evaluation, etc.... shall be the right and responsibility of the first party.
4. **Fee collection:-** That the fee fixed for the course shall be collected in installments. Fees collection and faculty fees shall be made by the second party.
5. **Profit sharing:-** The second party will give 75% of the total fees collected as profit to the first party.
6. **Retiring:-** That in any case any party is decided to retire from the agreement, they shall be required to give at least 6 months notice in writing to do so unless other wise mutually agreed upon them. However neither party shall have the right to do so, in a way that smooth completion of the Tax classes in progress at that time. Contrary to this agreement, if any party violates this agreement, the aggrieved party shall have the right to get the compensation from the defaulter. For that matter, N.Paravoor the place of the institutions shall be its jurisdiction.
7. **General conditions:-**

Whenever written notice to either party is required, such conditions shall be fulfilled by the mailing of notice by registered mail with acknowledgement due to the parties.

This agreement is executed in two numbers in English language. Each of which shall be deemed as original and the one and the same which shall be sufficiently evidenced for the same.


Nothing contained in this agreement shall constitute either of the parties to any other party without the written consent of the other party here to.
