The material will include hereafter all forms of e-waste and or e-scrap collected out of discarded electronic equipments of all kinds, including but not limited to IT equipments like printers, printer cartridges, faxes, copiers, spares, laptops, desktops, servers, mobile phones and all other electronic accessories of science labs in the college.

This MoU shall become effective on the date it is signed by the parties and shall be valid for three years and is extendable. Both parties shall review the status of the MoU at the end of three year period to determine any modification, whenever necessary. The period of validity of this MoU may be extended by mutual consent up to seven years. This MoU may be amended by mutual written agreement and may be terminated at any time by either party upon written notification consigned by the competent authority of the party initiating termination. Such a notification must be given to the other party at least six months in advance from the effective date of termination.
