## Analysis of Feedback 2020-21

### **Feedback of Students**

We have comments from the undergraduates and postgraduates that are currently enrolled. The students provided the following comments regarding the syllabus after the feedback form for the curriculum was used.

#### Overview

Students felt that each course's goals were very clear, and they could manage their workload. The majority of students felt optimistic about their ability to advance in this course. They are dissatisfied with facilities (toilets) provided at the college. They need more facilities for labs and classrooms.

About 10% of the total students are satisfied with toilet facility provided by the institute. Remaining are marked poor as mention. Building/classrooms provided by the institute are not easily accessible for students. About 62% say that library facility and number of books required for curriculum is quite well. Students are marked as there is no sufficient numbers of classrooms for disabled persons.
