

Feedback Report 2021-22

Internal Quality Assurance Cell of SNM College Maliankara has developed the feedback mechanism commencing with obtaining feedback from the various stakeholders - students, teachers, employers, parents and alumni through a structured based feedback form. Through a feedback committee, the IQAC gathers and analyses comments from all stakeholders. From the 2021–22 academic year, the college features an online feedback system. Following analysis of the input, comprehensive reports are created and sent to the concerned teaching staff, department head, exam in-charge, library, and university Board of Studies for improvement. Consolidated comments on many topics relating to various academic disciplines would be helpful when designing, redesigning, and revising the curriculum. All these feedbacks are well documented and recorded in the institute and the same report will be posted to the college website.

How do you rate the subject knowledge of our student working with you in relation to the Programme Curriculum?



The consolidate data is submitted by IQAC and placed before College Academic Council for taking actions. The feedback of each stakeholder will be analyzed and the suggestions needs to check for verification and will take possible incorporation in the functionalities of the institute.
